**POST GRADUATE COMMON ENTRANCE TEST - 2023**

**for admission to 1st Year / 1st Semester MBA / MCA /M.E. / M. Tech. / M. Arch Courses**

- 1) Pursuant to the Government Order No. ED 17 TEC 2018, Bangalore dated 13-03-2018, applications are invited from the eligible interested Karnataka and non-Karnataka candidates for admission to 1st year / 1st semester full time / part time MBA / MCA / M.E. / M. Tech. / M. Arch courses in the institutions affiliated Universities which will be notified by the Government of Karnataka for the year 2023-24. Candidates have to appear for the Post Graduate Common Entrance Test-2023 conducted by Karnataka Examinations Authority to become eligible for admission to these courses as per the provisions of the Karnataka Selection of Candidates for Admission to Master of Business Administration and Master of Computer Application Courses Rules, 2005, Karnataka Selection of Candidates for Admission to Master of Engineering (ME) and Master of Technology (M.Tech) courses, Rules, 2005.
- 2) **GATE qualified candidates from only Engineering and Technology discipline are eligible to take admission to Various M.Tech Programmes under VTU, Belgaum.** The candidates with valid GATE score should compulsorily enter application online to become eligible for admission to M.E. / M. Tech / M. Arch courses, **but they need not appear for PG CET-2023.** SC/ST/OBC reservation eligibility criteria are applicable only to those who become eligible as Karnataka candidates.
- 3) Non-Karnataka candidates are eligible to select ONLY the seats surrendered by the management if any, for admission to MBA / MCA courses. Non-Karnataka candidates will not be eligible for reservation. **Hence, if they have scored the required minimum 50% or above, fixed for 'GENERAL Merit' as per the qualifying criteria, then only they are eligible to register for admissions through KEA or for any other seats in the State of Karnataka.** Please note that SC / ST / OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.
- 4) In the qualifying examination, candidates should have obtained an aggregate minimum of 50% marks, 45% for SC, ST and Category-I of Karnataka candidates. If the qualifying marks assigned in terms of Grades i.e., CGPA / SGPA, ascertain the grade point awarded in the qualifying exam is equal or more than the required qualifying percentage of marks.

- 6) Interested and eligible candidates can register and apply online for PG CET-2023 **from 07-08-2023 (11.00 AM onwards) upto 17-08-2023, 11.59 PM.** Fee has to be paid by the registered and applied candidate **on or before 19-08-2023, 6.00 PM.**
- 7) Information Bulletin-2023 detailing Academic Eligibility, Original Documents to be produced for verification and other admission eligibility criteria are hosted on the KEA Website for the information of the candidates. The candidates are advised to verify the eligibility criteria before applying to any of the courses.
- 8) The information / particulars entered by the candidates online for PG CET-2023 will be deemed as "Final" and will be the basis for further process. No change in any information entered by the candidates will be entertained.

**NOTE:**

- 1) All the admissions and undergraduate Degrees to claim eligibility for admission to any of the PG courses are subject to approval of the Government / VTU / other respective University.
- 2) As per the letter from VTU, Belgaum dated 12-08-2014, to pursue M.Tech course on the basis of undergraduate programme from Aeronautical Society of India is NOT approved.
- 3) As per the letter from VTU, Belgaum dated 30-05-2014, who have acquired B.E. Degree through Distance Education Mode are NOT eligible for admission to M.Tech Courses.
- 4) Candidates who have passed the qualifying examination from Aeronautical Society of India and Associate Membership Examination of Institution of Electronics and Telecommunication (AMIET) will not be permitted seek admission to M.Tech. as per VTU, Belgaum letter dated 14-05-2018 .
