- · Minimum passing marks in CIE to be fixed
- Project valuation- Internal & External guide assessment shall carry 50 marks and Project report and Viva-voce 50 marks
- Maximum period for successfully completing the MBA program shall be within a
 period of five years instead of four years from the date of admission to the program.

Resolution No. 3- The Academic Council resolved to approve Examinations Rules and Regulations and the panel of question paper setters and examiners for MBA 1st and 2nd Semesters.
